
#### Gas market overview – Platforms to be used






#### **Gas Trading Platform and Neighbouring Systems**





#### Internal Organisation of the Gas Trading Platform







### Derivatives / Futures Trading Platform: Market Price Overview / Market Depth for a single Instrument and Spreads





#### **Trade Execution**




- Scheduling of Trade Sessions
  - Depending on market liquidity
  - Start with Opening Auction
  - Continuous trading over the day
  - Closing Auction
- Per Auction: "Pre-open" session
- Trading session may also be halted
- Schedule is pre-defined but can be manually overridden




# The Trayport ETS system provides the following statistics through its API:

- Last Traded Price & Volume
- Price change (difference in price between the last two trades)
- Highest Price Today
- Lowest Price Today
- Time of Last Trade
- Total Number of Trades Today
- Total Volume Traded Today
- VWAP (volume-weighted average price)


More precise data can be calculated based on individual order and trade data.





#### **Spot Trading Platform: Nomination System**













#### **Clearing Registration for OTC Trades**









- A regulated exchange hosts a market surveillance department which directly reports to the regulator in charge.
- Fraud cases:
  - Insider Trading
  - Market Abuse, types are:
    - Market manipulation through false or misleading information
    - Market manipulation through abusive squeeze / cornering
    - Market manipulation through ramping
    - Market manipulation through cross-market-manipulation
    - Market manipulation through wash trades
    - Market manipulation through circular trading
    - Lack of market liquidity leading to price peaks
    - Manipulation of an end-user relevant index at a market place







