12nd Exploration-Production Sector Consultation Meeting



- ➤ It was held online on November 18, 2020 with the participation of sector stakeholders, especially Minister of Energy and Natural Resources Mr. Fatih Dömez.
- Views are exchanged on the activities carried out in the Turkish Exploration-Production sector.
- Mr. Fatih Dönmez touched on the discovery of 405 billion cubic meters of natural gas and the oil and natural gas production figures of the last 18 years in his speech.
- Murat Kalay emphasized the positive effects of the discovery of the Black Sea on the sector and the 20th anniversary of PETFORM in his speech.



EY Turkey-PETFORM Recovery in Energy Markets, 2020 Outlook and Beyond Webinar



- A webinar was organized in cooperation with EY Turkey in order to examine the world economy under the impact of COVID-19 from a macroeconomic point of view and to evaluate current economic indicators in oil and gas markets and energy services.
- ▶ PETFORM Chairman Mr. Murat Kalay, EY Russia Deputy Manager Mrs. Olga V Beloglazova and EY Turkey Energy Services Consultant Mr. Batuhan Danışman participated as speakers in the webinar moderated by Mr. Erkan Baykuş EY Turkey Energy Services Leader.



8th Black Sea Oil and Gas Conference



- Secretary General Mr. Gökhan Soruş made a presentation on «Turkish Exploration and Production Sector and Turkey's Black Sea Natural Gas Discovery» at 8th Black Sea Oil and Gas Conference was held on 08 November 2020.
- Mr. Soruş gave details about Turkey's overall energy balance, the share of domestic gas production in total consumption, exploration-production sector investments, drilling in Turkey and Black Sea discovery in his presentation.



Natural Gas Discovery in the Black Sea Webinar



- A webinar was held in order to examine the strategic, legal, financial and technical dimensions of TPAO's exploration of natural gas in the Black Sea.
- PETFORM Chairman Mr. Murat Kalay, Retired Ambassador Mr. Mithat Rende and Former BOTAS General Manager Mr. Gökhan Yardım participated as speakers in the webinar moderated by Mr. Murat Yazici Yazıcı Attorney Partnership's Founding Partner.
- Mr. Kalay, gave information about the previous studies on the fields in the Black Sea, and also touched on the issues of the phases necessary for the discovery to be commercial and for the start of production and how this production can be financed.



E&P Group Activities



- ➤ 12nd Exploration-Production Sector Consultation Meeting was held online with the participation of Minister of Energy and Natural Resources Mr. Fatih Dönmez.
- ➤ E&P Group meeting was held on September 02, 2020 under the chairmanship of Murat Kalay.
- A formal letter regarding the follow-up of the matters in hand in the 12nd Exploration-Production Sector Consultation Meeting was prepared and shared MENR and GDMPA.
- The proposals amendment for the «Omnibus Bill for Amendment on Electricity Market Law and Other Laws» sent to the Turkish Grand National Assembly Industry, Energy, Natural Resources, Information and Technology Commission were followed up by our Secretariat and the relevant changes were evaluated under our E&P Group.



Gas Group Activities



- Two group meetings were held on 11 August and 16 October under chairmanship of Didem Kalkan Erdem.
- Five consultation meetings were held with EMRA and EXIST in the preparation process of Futures Market, and proposals were prepared with the Joint Meetings of the Legislation and Liberalization Sub-Working Groups regarding the draft procedures and principles.
- Proposal letter regarding the drafts published by EMRA for the Natural Gas Market Licensing Regulation, Natural Gas Market Distribution and Customer Services Regulation and Organized Wholesale Natural Gas Sales Market Regulation has been prepared and shared with EMRA.
- Formal letter requesting extension regarding the 2021 capacity reservation has been prepared and shared with EMRA.
- The articles of «Omnibus Bill for Amendment on Electricity Market Law and Other Laws» concerning our gas market have been examined in detail under the Gas Group.
- Within the scope of our study calendar, our study on "Pricing of End Users and Implementation of Eligible Consumer Rights", which is our second study topic, was finalized by reporting and shared with the authorities of MENR, EMRA and BOTAS.


